THE KING AND THE BLIND.

ROYAL VISIT TO INSTITUTE FOR THE AFFLICTED.

The King, accompanied by the Queen, opened the new buildings of the National Institute for the Blind of Great Portland-street.

His Majesty, in reply to an address which mentioned how the late Dr. Arncliffe had developed the Braille system, joined heartily in the tribute to that gentleman's memory, and said: "A great service was rendered to humanity when Louis Braille devised the system of reading and writing which partially restores to the blind the lost means of intercourse with their fellows."

Subsequently their Majesties inspected the factory in which Braille processes are carried out. They saw the exhibits of old and new books and apparatus for the use of the blind, and witnessed demonstrations by the blind workers of book-production—including illustration—short-hand and typewriting.

The Royal visitors stopped to watch a blind girl typist and shorthand writer, who punched out Braille shorthand from dictation, "read" it with her fingers, and typed it out on an ordinary machine.

Mr. C. Arthur Pearson dictated a letter to the typist, which she took down in shorthand and afterwards typed. Their Majesties read the letter and congratulated the operator.

The King showed great interest in examining the blind Boy Scouts, who formed a guard of honour.

ACTION FOR SEVENTENCE.

Excursion ticket law was the subject of an interesting action heard in the City of London Court. The Great Eastern Railway Company sued Mr. Michael Sidney, of Balham, for 1s. 6d. excess fare.

It was stated for the company that the defendant travelled from Liverpool-street to Ongar. He had taken a cheap excursion ticket from Liverpool-street to Loughton, for which he paid 1s. On arrival at Ongar he gave up half his excursion ticket and tendered 11d. excess fare, which was refused. The single fare to Ongar was 1s. 11d., and the defendant was getting to Ongar at a cheaper rate by 6d. It was admitted that there was nothing to prevent the defendant from getting out of the train at Loughton, where he could have obtained another ticket for 11d.

The defendant said that, having travelled from Liverpool-street to Loughton, he had completed his contract with the company, and by going on to Ongar he was travelling without a ticket.

The Registrar held that the defendant had committed a breach of contract in travelling through and not stopping at Loughton. Mr. Sidney had paid 11d. into court, and judgment was entered for the plaintiffs for 7d. in addition. There were no costs.
